

Polisi Bioamrywiaeth Cyngor Cymuned Llandysiliogogo

Mae Cyngor Cymuned Llandysiliogogo yn gweithio i ymateb i anghenion lleol i wella safon bywyd y pentrefi a wasanaethwn.. Rydym yn gwneud hyn drwy hyrwyddo datblygiad cymunedol a gweithgareddau cymdeithasol, gan gynnwys cefnogi nifer o grwpiau chwaraeon, diwylliannol a chymunedol sy'n chwarae rhan amlwg ym mywyd y gymuned.

Mae'r Cyngor yn ceisio cymryd cyfrifoldeb dros les y gymdogaeth leol ac yn gweithio ar lefel leol. Mae'n haen llywodraeth leol sydd agosaf at y bobl, a hithau'n haen islaw'r Cyngor Sir. Mae eu gwaith yn perthyn i dri phrif gategori:

- a) cynrychioli'r gymuned leol
- b) darparu gwasanaethau i ddiwallu anghenion lleol
- c) ymdrechu i wella ansawdd bywyd yn y gymuned.

Mae'r prif swyddogaethau a wneir gan y Cyngor yn cynnwys:

- Ystyried materion cynllunio;
- Gweithio ar y cyd â Phriffyrdd y Sir ar fesurau tawelu traffig a gwelliannau i'r briffordd;
- Gweithio gyda'r heddlu i ddiogelu'r gymuned;
- Delio gyda materion lleol a godwyd gan y gymuned;

Llandysiliogogo Community Council Biodiversity Policy

Llandysiliogogo Community Council is working to respond to local needs to improve the standard of life in the villages we serve. We do this by promoting community development and social activities, including supporting a number of sporting, cultural and community groups which play a prominent part in the life of the community.

The Council seeks to take responsibility for the well-being of the local neighbourhood and works at a local level. It is a local government tier which is closest to the people, being a tier below the County Council. Their work falls into three main categories:

- a) representing the local community
 - b) delivering services to meet local needs
 - c) striving to improve quality of life in the community
- The main functions undertaken by the Council include:

Maintaining open spaces;

- Considering planning matters;
- Working in conjunction with County Highways on traffic calming measures and highway improvements;
- Working with the police to safeguard the community;
- Dealing with local issues raised by the community;

- Darparu a chynnal byrddau eistedd a rhybuddion cyhoeddus;

- Enwebu cynrychiolwyr i'r ysgol gynradd leol;
- Cynnal a chadw feinciau a'r ardaloedd o'u cwmpas

Mae'r Cyngor wedi ymrwmo i fioamrywiaeth ac ardaloedd naturiol. Rydym yn hyrwyddo cynaliadwyedd a bioamrywiaeth drwy ddilyn nodau cynaliadwyedd ac arferion cynaliadwy pryd bynnag y bo modd sy'n cynnwys gweithredu fel ymgynghorwr ar geisiadau cynllunio.

Ein targedau yw:

1 Adolygu ein gweithdrefn torri gwair ym mhlwyf Llandysiliogogo i annog blodau gwylt a phlanhigion eraill sy'n gyfeillgar i beillwyr tra hefyd yn darparu gorchudd i famaliaid ac ymlusgiaid bach.

Byddwn yn gweithio gyda Chyngor Sir Ceredigion i hyrwyddo'r amcanion hyn;

2 I ystyried materion bioamrywiaeth wrth ystyried llunio grantiau / rhoddion;

3 Byddwn ni'n cymryd lle unrhyw goed y mae'n rhaid inni eu tynnu am resymau diogelwch / clefyd coed yn ystod y flwyddyn.

- Providing financial assistance for various local voluntary organisations;
- Providing financial assistance for Charities in the community;
- Providing and maintaining public seating and notice boards;
- Appointing representatives to numerous local and outside bodies;
- Nominating representatives to the local primary school;
- Bus / waiting shelters;

The Council is committed to biodiversity and natural areas. We promote sustainability and biodiversity by pursuing sustainability goals and sustainable practices whenever possible. These include acting as a consultee on planning applications and promoting litter picking events

Our targets are to:

1 Review our grass mowing regime in Llandysiliogogo to encourage wildflowers and other pollinator friendly plants while also providing cover for small mammals and reptiles. We will work with Ceredigion County Council to promote these objectives;

2 To consider biodiversity issues when considering grant making / donations;

3 We will replace any trees that we have to remove for safety reasons / ash dieback during the year.
